Sir,

In continuation to the communication of UGC on the above matter and the presentation of University of Mysore, Karnataka 'Learning Platform' on the basis of 28 Assessment Parameters to various provisions of the Regulations held on 15th October, 2019 before a duly constituted Technical Expert Committee, I am directed to inform you that based on the recommendation of Technical Expert Committee and its approval by the Competent Authority, the learning platform student1.uni_mysore.in/U-18 evolute proposed by University of Mysore, Karnataka is approved. A copy of recommendation sheet of Technical Expert Committee is enclosed herewith for your reference.

Apart from this, it is also informed that the observations of the Screening Expert Committee, on the proposal submitted as per the provisions of sub regulation 6(1) of UGC(Online Courses or Programmes) Regulations, 2018, duly approved by the Competent Authority has already been communicated to the HEI through UGC DEB portal. In order to process the proposal further and to ensure compliance to the provisions of the UGC (Online Courses or Programmes) Regulations, 2018, the HEI is requested to attend interface meeting with a duly constituted Expert Committee, the schedule of the meeting on 05.11.2019 from 10.30 a.m. onwards at UGC, 35 Feroze Shah Road, New Delhi. The HEI is requested to bring compliance report on the observations as mentioned above, for the consideration of the Interface Expert Committee.

It may be noted that this letter is only for approval of learning platform proposed by the HEI and SHALL NOT be considered as a letter of recognition to offer Online Courses/Programmes under any circumstances. As stipulated under Sub-Regulation 3 of Regulations 6 of the UGC (Online Courses or Programmes) Regulations, 2018 "No Higher Educational Institution shall offer any Online Courses or Programmes and admit students thereto unless it has been granted recognition by the Commission and admission shall not be made in anticipation of the approval".

This issues with the approval of the Competent Authority.
